- ▶ Overnight tours and operations involving persons age 21 and older
- ▶ Groups with vocational school exposure (no overnight school)
- ▶ Groups with lessor's risk exposure

INELIGIBLE RISKS – Risks with the below characteristics may be eligible for certain coverage lines

▶ General Liability

- Annual revenues greater than \$3,000,000
- Risks with performances that end after 12:00 am
- Risks with international operations or performances
- Event planners, booking agents or promoters
- Any previous claims or allegations of sexual or physical abuse
- Special effects with pyrotechnics/fireworks or aerial acts over the attendees
- Construction of scenery, backdrops or stages over three stories in height or use bulldozers, backhoes, excavators or cranes
- Buildings that lack two means of egress from any floor (including basement) having public access
- Risks with exhibits, presentations or performances involving wild, exotic, non-domesticated or saddle animals
- Greater than 50,000 square feet for Museums or Art Galleries
- Risks with any participation by the public in any display, presentations, performances or exhibits
- Risks in AK, WV or LA
- Applicants that have any operations, instructions or training involving cheerleading, gymnastics or martial arts
- Applicants that provide permanent or temporary housing for staff or performers
- Performances in vacant building

▶ Property

- Fine Arts schedule for Museums or Art Galleries
- Risks with on-premises welding cutting or spray painting operations
- Property limits greater than \$3,000,000 non-coastal, \$500,000 coastal
- Buildings with aluminum or knob and tube wiring
- Buildings not having 100% of the wiring on circuit breakers
- Risks in AK, HI or LA

▶ Non Profit Directors and Officers/Employment Practices Liability

- Organizations administer or sponsor any insurance programs
- Organizations involved in any accreditation or standard setting activities
- Organizations involved in any labor/union negotiations or collective bargaining activities
- Risks in LA

- ▶ Property for protection class 1-8 is \$3,000,000
- ▶ Property for protection class 9-10 is \$250,000
- ▶ Property values up to \$500,000 per location for defined Coastal Zones (wind exclusion applies)
- ▶ General Liability limits up to \$1,000,000/2,000,000
- ▶ Molestation and Abuse sub-limit of \$50,000/50,000
- ▶ Directors and Officers/Employment Practices Liability up to \$5,000,000 (the EPL limit may not exceed the D&O limit)

- ▶ Representation of incurred loss history for the past five years
